

Bubble Football Waiver

Consent (Signed by parent or guardian if participant under 18) ***THIS IS A LEGAL CONTRACT — READ BEFORE ACCEPTING THE TERMS***

These terms and conditions affect your legal rights. It is therefore important that you read and understand them.

Activitots Club LLP is a supplier of recreational services. The recreational services include participation in bubble football, dodgeball and other sporting activities ("recreational activities"). By purchasing a ticket for or by using any of the equipment supplied by Activitots Club LLP, you agree to be bound by these conditions.

1) I acknowledge that the participation in the activities provided by Activitots Club LLP entails known and unknown risks that could result in physical or emotional injury, paralysis, death or damage to themselves to property or to third parties. I further acknowledge that the activities provided by Activitots Club LLP require a reasonable level of fitness and ability.

I understand that although all reasonable steps will be taken to ensure the safety of participants, Bubble Football is a physical activity that involves the risk of personal injury. These risks include, but are not limited to collisions with other players or equipment, falling, tripping, or rolling within the bubble suit, minor to serious injuries including bruises, sprains, or potential head, neck, or back injuries.

- 2) I hereby agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.
- 3) I confirm that I have disclosed any relevant medical or physical conditions that may affect my child's participation.
- 4) I understand that all participants must follow safety instructions and behave responsibly. Any unsafe or disruptive behaviour may result in removal from the activity without refund.
- 5) I acknowledge that Activitots Club LLP is not liable for damage or loss to myself, third parties or property however incurred whilst undertaking activities.
- 6) If the participant is a minor, I agree that this Release of Liability and Assumption of Risk Agreement ("WAIVER / RELEASE") is made on behalf of that minor participant and that all of the releases, waivers and promises herein are binding on that minor participant. I represent that I have full authority as Parent or Legal Guardian of the minor participant to bind the minor participant to this Agreement.
- 7) I expressly agree and promise to accept to be responsible for any and all risks existing and subsisting in the activity from time to time and acknowledge that their participation in the activity is voluntary and that they elect to participate despite of the risk and agree to accept the

consequences of so doing save only to the extent that Activitots Club except liability for death or personal injury caused by the company's negligence and / or breach of statutory duty.

- 8) I agree to provide the protective clothing required to participate in Bubble Football, of full length trousers and gloves; and understand that I failure to provide protective clothing will result in removal participation in the activity without refund.
- 9) To the maximum extent permitted by law, but subject to the non-excludable consumer guarantees implied pursuant to the UK Consumer Law, in no event will Activitots Club LLP or its employees, directors and agents be liable in respect of any claim for any indirect or consequential loss or damage including without limitation personal injury, financial loss (such as loss of profits or use of capital or revenue or otherwise), or for any punitive, exemplary, special, incidental or consequential loss or damage whether such liability arises in contract, tort (including negligence), equity, breach of statute or statutory duty or breach of any consumer guarantees.
- 10) This Waiver/disclaimer will be governed by and construed in accordance with English law and any disputes relating to this disclaimer shall be subject to the exclusive jurisdiction of the courts of England.

By consenting to having read this document I accept all terms and, I acknowledge that if anyone is hurt or property damaged during my participation in this activity, I may be found by a court of law to have waived my or the minor participant's right to maintain a lawsuit against Activitots Club LLP or any RELEASED PARTIES on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood and agree to comply with the rules of Activitots Club LLP, and I agree to be bound by its terms.
